3. **All artists** must sign an Insurance waiver for stage liability prior to or on the day of the event.
4. **All artists** must sign an Affidavit of Eligibility stating that the artist music, is the artist's original work and that he/she holds all rights to the song and Fiesta Del Sol San Diego will not be billed by **ANY** of the artists associations (ASCAP, BMI, etc...).
5. A parent or guardian must undersign affidavits of **any artist** under 18 years of age. Affidavits are subject to verification of **Fiesta Del Sol San Diego** and its agents.
6. **There will be no sound check prior to the event.**
7. **For each (1) MINUTE Artist / Performer / Band is Late to start, for scheduled start time on stage - (5) FIVE MINUTES will deducted from performance time. *** THIS WILL BE STRICTLY ENFORCED******
